1. *Every horse must have an up-to-date coggins test, please do not unload until we have confirmed your paperwork.*
2. *No Smoking ANYWHERE on the show grounds. We have severe asthmatics and migraine sufferers, please be considerate.*
3. *ASTM/SEI Helmets and a signed entry form are required for ANYONE mounted on the show grounds that has NOT signed a helmet waiver. It is Emerald-Glen's policy to highly encourage safety precautions in equestrian sports.*
4. *Entries will not be allowed into the arena until we have a signed entry blank.*
5. *All classes are covered by the rules of the USEF /WDAA Rule Book and then the WNEPHA Rule Book.*
6. *A \$25.00 processing fee will be charged on all returned checks for any reason.*
7. *All entries understand that the management will not be responsible for any accident which may occur to any rider, driver, groom, attendant, or equipment at the show.*
8. *Attire is Semi-Formal see <http://www.wnepha.com/dressageseries.html> for details. Freestyle costumes encouraged. Leg wraps allowed in freestyles.*
9. *Spaces are Limited. Entries close when all spaces are filled. We go by post-mark date. Your time will be emailed and posted on Facebook two days prior to the competition..*
10. *Please, keep dogs on a leash.*
11. *We also request that you pick up any "leavings" from your horse. There will be wheelbarrows and forks throughout the show grounds for such purposes.*

Professional Test of Choice: All professionals will choose their tests based on the horse's level of competition. There will be 2 separate Professional Year End Awards: one for the highest number of points for a horse/professional rider combination, another for the highest overall number of points for a professional, regardless of number of horses shown.

WNEPHA Points will be awarded as follows:
We will be using the 7, 5, 4, 3, 2,1 point system. Meaning: scores of 75% and up=7 pts; 70% -74.999% = 5 pts; 65% - 69.999% = 4 pts, 60% - 64.999% = 3 pts, 55% - 59.999% = 2 pts, 54.99% and below= 1 pt.
